Here's a quick summary of some of the deals we've done this year:

**Lifspot Health (LSH):** IPO at 20c, a brilliant debut at 43c High on day 1, we feel there is going to be some exciting movements for the stock in 2018

**Golden Mile (G88):** listed at \$0.20, reaching a high of \$1.28 a month ago, over 600% return

**Great Western Resources (GTE):** Entered at 1.1c placement and exited at 2.7c within 13 weeks, a nice 145%

**De.Mem (DEM):** IPO at 20c, hit 50c within 1.5 months. Lots of big contracts coming into the company, 2018 will be a great year for De.Mem.

**Novena Healthcare (previously known as PPP):** Entered at SGD5 per share, been converted to USD5 and now standing at USD7. Finalising the Shanghai hospital merger and acquisition.

**Global Asset Resources (GA8):** IPO in progress, targeting a listing in late-2018 at \$0.20 focusing on the international mining in developing regions. This is one that you don't want to miss out on...

**Magnum Mining & Exploration (MGU):** placement at 3c and now trading at 6c, and more to come.

**National Currency Exchange (NCX):** one where you can buy/sell your crypto and coins with the strictest Australian regulatory framework. We see great upside for this Exchange in 2018 and one to watch.

**Skylight Performance (Bahamas) Fund:** our Bahamas private fund trading our own fund - small AUM and yet we are performing more than 50% (net of the hefty fees) since inception. We are upgrading it to Professional fund and accepting Sophisticated Investors in Q2, 2018.
